To be eligible, all films submitted must have been completed after July 1, 2013. Films with significant non-English dialogue must be accompanied by on-screen English subtitles.

Films should not have been previously shown on television or the internet.

Entries must be sent electronically and preview materials postmarked by these dates.

*There is no entry fee for submissions sent by May 31, 2015 (12:00 p.m. EEST). There is a Late Submission fee of 20 Euros for entries sent between May 31 and June 10 (12:00 p.m. EEST).

PROCESS FOR SUBMISSION

Entries must be submitted in one of three categories:

Feature Film · Documentary · Short Film

- Feature Film and Documentary preview copies should be sent as protected links. If this is not possible, screeners in these categories can be submitted as DVD or BD.
- Short Film preview copies must be sent only as protected links. The Festival DOES NOT accept DVD or BD screeners for Short Films.
- Please provide 2 production stills from the film.
- Please provide brief and longer synopses of the film, the filmmaker's biography, full production credits and contact information. Be thorough! This information will be used in the Festival catalogue should the film be selected.

SELECTION

We are looking forward to viewing your film and considering it for IFFP 2015! The Festival will notify all applicants who have been selected to participate before the official press conference, which will take place around **July 1, 2015**. We will contact applicants by email using the email address provided on the Entry Form. Please ensure that your email account will not filter out the domain IFFP.GR (as in submission@iffp.gr).

If selected, a screening version of the film (Quicktime Prores 4:2:2 video file, DCP-24, or other format agreed upon in advance) must be received by the festival committee by **July 10, 2015.** Please clearly indicate the aspect ratio of the film. The Festival may, but is not required to, permit certain selected films to be screened in alternative formats.

The cost of shipping prints/hard drives to the festival must be met by the Sender. The Festival will pay for one-way shipping of all prints/hard drives by forwarding them to their next destination within two weeks of the conclusion of the festival. Any customs or duties charges will be the responsibility of the filmmaker. We do not pay screening fees for films submitted to the festival.

All films chosen to be part of IFFP 2015 must agree to use the "Official Selection" logo of IFFP on all publicity.

Please note that decisions of the Festival programmers and selection committee are final and unreviewable. The Festival is not obliged to provide any feedback regarding the selection process.

The Festival accepts full responsibility for protecting the copyrights for the period of time that the films are in the Festival's possession, and will act to ensure that no theft or breach of copyright will occur.

The applicant of a selected film agrees that up to three minutes of their film may be used by the Festival in promotional activities including screening a clip on television and/or on the Festival's website, and/or on the screens at the Festival venues (trailers included).

SHIPPING INSTRUCTIONS FOR DVD/BD SCREENERS

(Feature Films and Documentaries only)

All films must be sent by way of prepaid shipping. The Festival cannot accept shipments incurring expenses for terminal charges, duties, taxes or customs brokerage. Please clearly indicate on all waybills that transportation and customs charges are to be billed to the Sender.

The Festival is not responsible and bears no liability with respect to clearance of shipments through Greek/EU customs, and we recommend applicants take the following steps to avoid problems and delays:

- a. Label the outside of your package, and indicate on the invoice: FOR FESTIVAL PREVIEW ONLY NO COMMERCIAL VALUE
- b. Value the package at 1 Euro

Label your discs with the title of the film, running time and contact information. Does the disc play? Please check! Please do not send film prints, master tapes or other originals for selection. Unfortunately the Festival cannot confirm receipt of entries nor are we able to return preview copies and press kits.
