SUBMISSION GUIDE

Entries may be entered as an on-line screener or submitted on DVD NTSC – NO PAL - Foreign language work must be dubbed or subtitled in English. Please do not send any paper press kits or any other print materials until they are requested by the festival.

SHIPPING GUIDE

The responsibility for the shipping cost of any and all material(s) is that of the entrant. All material(s) must be prepaid. Any and all C.O.D's will be refused. All DVDs must be labeled with the title of the work, run time and the name of the director.

SELECTION & NOTIFICATION GUIDE

If you are selected we will post it on our website and notify you by email. If selected we prefer blu ray or a downloadable file – NO PAL. We will notify you if you are not accepted as well.

AWARDS

Awards for BEST in each category, "Spirit of Queens" and "Best of Festival" awards.
