Lanús International Film Festival is an annual film festival that is held in Argentina and was established with the purpose of showing films that contribute and change the world through the power of cinematography. It is an annual space for exhibition and film production, which aims to encourage the growth of local and international filmmakers within a professional, educational and cultural framework. LAFIC is characterized by national and international premieres of fiction, documentaries, animations, music videos, both in feature films and in short films represented by countries around the world, by emerging filmmakers recognized by a series of prizes awarded by the jury and Of the public.

#### **BASES**

The filmmaker declares that he has the authority and legal capacity to compete with his production because it belongs to him and that this participation does not violate the legal rights of any person or entity.

2 . - The Calling Period begins on **September 30, 2017 and ends on February 20, 2018**. The Festival will begin on March 1 and end on March 4, 2018. Subsequently, winning films will be shown in institutions and media.

10 - Registration at the festival constitutes a legal authorization that entitles the organization to exhibit competition films, without limitations, providing due credit to the authors.

Winners will be announced during the closing night of the festival on March 4, 2018, and also notified by e-mail.
