REGULATION

1. Organization

The Festival is organized by the Non-Profit Organization ARMENIAN FOUNDATION FOR PROMOTION OF CINEMA AND TV FOR CHILDREN AND YOUNG PEOPLE ROLAN BYKOV FOUNDATION with the support of MINISTRY OF CULTURE OF ARMENIA and various public organizations, institutions and private companies.

2. Inscription of Works

- a) The inscription of audiovisual material is free. Armenian and international works are entitled to participate in the official competition in film as co-productions made during the years 2018- 2021.
- b) The works can be presented in the official competition or else in the non-competitive section of the festival.

3. Entry's Conditions:

*The participant entries with films on DVD format for the preselection of the Festival should be sent only **BY NORMAL POST** prior to August 1, 2021:*

Entries should also include by post:

- ***The completed Entry form of the film***
- ***Photos of film director /1-2/***
- ***Director's CV***
- ***Photos from the film***
- ***ENGLISH subtitles of the film***
- ***List of dialogues in ENGLISH***
- ***Synopsis of the film in ENGLISH***
- ***Copy of the film on DVD format***
- ***Paper copy of the entry form***
- ***Posters***

6. Duration of works

We will apply to the present festival the consideration for “feature film”, the films of 55’ or plus duration. Those of less duration will be considered “short films”

The result of the selection will be notified to the registered participants before October 1, 2020.

7. Requirements for the exhibition copies

The copies for exhibition must comply with the following requirements:

- Film format: the films selected must be presented in **DVD** including optical sound exclusively. In case of being subtitled, the subtitles must be only in ENGLISH.
