Regulations

II international shorfilm festival «Kinosmena» in Minsk 2017.

Contract clause 1

An annual international shorfilm festival «Kinosmena» in Minsk (further - Festival) is a viewing tender of the films, which have undergone preliminary selection and received positive expert evaluation.

Contract clause 2

Festival tasks:

- Adjustment of the international cultural ties;
- Development of creative contacts;

- Exchange of experience and the ideas between cinematographers of the countries, which take part in festival;

- Providing independent author's movie;
- Promoting Belorussian cinematography.

Contract clause 3

Directorate of the Festival establish program of the work of the Festival, the order and the place of demonstration of films.

Contract clause 4

Program of the Festival includes:

- An international competitive program of fiction films;
- An international competitive program of fiction films by Belorussian authors;
- Workshops;
- Creative meetings of authors with the audience;
- A press conference;
- An entertainment program.

Contract clause 5

Fiction shortfilms, which are not longer 15 minutes and are made not later 2 years, are accepted for participation in the Festival's competitive. The screening committee on the discretion can include in the competitive program of the Festival films with a bigger duration and earlier production if considers that they will decorate the program of the Festival.

The number of works from one person isn't limited.

Films, despite the professional level of author (professional or amateur), are accepted for participation in the Festival's competitive.

Films, which promote violence, immorality, unhealthy way of life, racial, race or religious strife, are not allowed to be accepted for participation in the Festival's competitive.

Contract clause 6

Participator, which submits the application, guarantees presence exclusive property rights on the sent Film, guarantees that nobody interferes with transfer of property rights on the Film to the Directorate of the Festival.

Responsibility for copyright violation in the relation to the sent Film lies on the participator, which has sent the Film.

Contract clause 7

Order of taking and selection films for participation in the competitive (out-of-competition) program of the Festival is made on a free basis.

At the same time the owner of the property rights agrees for:

- representation of fragments of the film (up to 10% of duration the film, but no more than 3 minutes) on television, the official site Festival and in other promotional materials for promotion of the Festival;

- using some screens from the film in promotional materials of the Festival (catalogs, advertizing booklets, in multimedia representations, etc) after the Festival.

- hire of the Film, which means public submission /public display of the Film Фильма by means of the film projection equipment in competitive or out-of-competition display with collection from the audience of a payment for viewing of the Film or without in terms till 31.12.18.

- providing to other persons (sublicenses) right to use of the Movie in frame work of the program of the Festival, for the purpose of the message of the Movie to general data in terms till 31.12.18.

Contract clause 8

To take part in the Festival you need to provide:

- Request questionnaire of the participant;
- File of the Film;
- File with subtitlings;
- -3 photos from the Film;
- Poster (poster) of the A3 form.

Films, which are made in Russian, Belorussian languages, are accepted without subtitlings.

Films, which are made in others languages, are accepted in languages the original with the English subtitlings if original language differs from English.

Contract clause 9

Technical requirements and order of providing materials:

- the file of the film provides in the MPEG-4 (codec h264, h265, x264 or similar) form, up to 2 GB. In case the film is chosen in one program, the Directorate can ask for the film in better quality;

- the file with subtitlings provides in the doc.form in English language;

- all the materials of the participator fill online according to the reference

http://www.kinosmena.by/ru/addmovie, through the festival platform filmfreeway.com or deliver to the Directorate of the Festival (220038,Misnk, Dolgobrodskaya,4 street, «Smena»)

- films are accepted in the form of the link to the platform Vimeo,

YouTube, file hosting service;

- if necessary the disk with the film and the request can be sent to mail. It is necessary to contact the Directorate of the Festival for refining of details and approval;

- the mark «No commercial value, for cultural purposes only» must be done on an envelope. Sent disks do not return. Sending the materials by means of express mail demanding customs registrations by the recipient can be performed only in coordination with Directorate of the Festival

- in particular cases owners of the film can bring them on the Festival independently. The owner of the film is obliged to provide the film copy for 2 (two) days of participation in the program of the Festival.

Contract clause 10

The Directorate of the Festival establish prizes and awards:

- 1. The Grand Prix of the Festival and «Gold Kinosmena» for the best film on a result of vote of jury and audience.
- 2. «Silver Kinosmena» for the film, which took the second place following the results of the vote of the audience.
- 3. «Silver Kinosmena» for the film, which took the second place following the results of the vote of the jury.
- 4. Gold «Kinosmena» in Belarus the best belorussian film following the results of the vote of the audience and the jury.
- 5. Silver «Kinosmena» in Belarus the film, which took the second place following the vote of the jury and the audience.
- 6. Prize from Belorussian Union of cinematographs.
- 7. Prize following the vote of the mass-media members.
- 8. Prze following the online vote for the best Belorussian film.

The vote of the audience and the jure, which is made up from leading domestic and international cultural figures, estimate films in the competitive program. The Directorate of the Festival establishes the number of the jury.

The chairman of the jury has 2(two) voices.

All the members of the jury promise to abstain from public statements concerning competitive pictures before closing of the Festival.

Contract clause 11

The winner of the international competitive of the Festival receives «Big Golden» figurine, the diploma and cash bonus of 1000 US dollars.

The winner of the international competitive of the Festival receives «Small Golden» figurine, the diploma and special prices.

Other winners of the international competitive of the Festival receives «Silver» figurine, the diploma and prizes from sponsors and partners of the Festival.

Contract clause 12

The Directorate of the Festival at any time can make the decision about deprivation of any accredited person of accreditation and to limit it presence on events of the Festival without explanation.

Contract clause 13

The participation in the Festival means consent with all articles of these Regulations.
