

Tri-Cities International Fantastic Film Festival 2013 Offical Rules & Entry Form • October 2013

In 2013, The Tri-Cities International Fantastic Film Festival (TCIF3) begins its sixth year under the promot-

ers and filmmakers that made the 1st and 2nd Annual RadCon Fan Film Festival a great success. Our motto as always is; "To spotlight short films made by fan with limited budgets, but unlimited imagination!"

Please read the following carefully.

General Rules for entry:

1. Films submitted should be in one of the following categories:

- Short Film (under 10 minutes)
- Short Film (over 10 minutes; under 60 minutes)

2. Films will be reviewed by TCIF3 staff.

3. The submission must be accompanied by the official entry form and \$20.00 (US) entry fee. Two (2) copies of the submitted film must be sent.

4. To be accepted; submitted films must be completely edited and in their final completed form.

5. Entry fee covers one film and/or trailer by submitter.

6. Films can be Live action, animation or a combination of both.

What to send:

• Two (2) copies of your film must be sent. Films should be submitted via mail or over the net on DVD/H.264 file with electronic press kit to the address listed. Please make sure your DVD plays on other computers or DVD players.

- Please include a brief synopsis of your film on a separate sheet of paper not to exceed 50 words, along with a brief bio sheet on filmmakers (director or writer) and one (1) production still for use in any potential publicity. Putting this info on a CD in electronic form is also acceptable.
- All films must be postmarked by the deadline, September 1st, 2013, and be accompanied by a signed entry form, entry fee and any paperwork. Filmmakers with accepted entries will be notified around mid September. The complete schedule of films will appear on the TCIF3 website, and in the onsite programbook.

Additional information:

All films will be shown via video projection in a 300 seat theater setting. Preferred format for screening is DVD, Region 1.

If your film is accepted, free professional media memberships for TCIF3 will be granted to those appearing to discuss their film.

All scheduling of selected films is at the discretion of the festival programmers.

Submitted films cannot be returned. And may be used for present or future promotional purposes.
