By submitting your film to **boyOHboy** [B.O.B.] films festival, you acknowledge that you have read all the following, and that you agree to all of our terms and of the festival rules. For your entry to our festival to be fully validated, you must **PRINT** these pages, **SIGN** them with the **hand-written** mention "I accept these terms", then **scan it** and **send it back** to us at filmmakers@boysinfilms.com

— B.O.B. is a **GAY BOYS** film festival, your film must therefore contain at least one gay boy character in the story. We now accept submissions. The [only] deadline to submit your film for the festival is August 30, 2020.

— You must be able to provide an HD screener (minimum 1920p, but 4k or DCP preferred though) and be able to submit a working link for us to download your film (link must be working and available until the last day of the marathon). In the event of a change URL, please advise us immediately, as your participation will be terminated otherwise.

We do not accept DVD nor Blu-Ray screeners.

Screener will be accepted ONLY if you have signed this present entry-form and acknowledged & accepted our present terms.

- The submitter is responsible for the submission. If the submitter is not the author nor the holder of the rights for the film, then he/she is obligated to provide a written agreement from the author and the holder of the rights for the film, in order for us to accept the submission. For your film to be taken into consideration by our selection team, your submission must include:
  - the final HD screener version of the film without any subtitles encoded on the video (subtitles must be provided in separated files),
  - the synopsis.
  - a PUBLIC Vimeo or YouTube or Dailymotion link to the TRAILER,
  - [if possible, meaning required but not mandatory] a short bio of both the film director and of the 2 or 3 main characters of the film,
  - the film poster and some good quality stills (minimum 200dpi) that <u>you authorize us to use at no cost</u> for the promotion of both your film and our events (which include our advertising promotional mediums such as posters, flyers, articles...).

It is the submitter's responsibility to make sure that these requirements are met: only the submissions that contain all the necessary materials will be validated. We will not insist on receiving what is not provided: if submission is not complete, it will be cancelled with no further notice.

- ALL FILMS (even English-speaking) MUST provide English subtitles, in a separate file (meaning NOT encoded on the film). Failure to provide **approved and working** English (at the very least) subtitles **in an external file**, before the submission deadline, will result in disqualification.
- Should your film be accepted in the 2020 edition of B.O.B., you grant us the right to utilize an excerpt (both the audio and the video) from your film for promotional purposes, on any support and in any media promoting B.O.B. 2020 and the following editions.

Each accepted film may be shown more than once during the festival, with the possibility of an "encore screening" if requested by the audience and/or the jury.

Scheduling is purely at the sole discretion of the B.O.B. staff.

Simply by entering your film to be considered in our festival you immediately grant the organizer of B.O.B. the right to broadcast your film (to journalists and partners for example) as many times as necessary, before, during and after the festival, in order for us to promote the festival.
