

7th International Short Film Festival

Official Short Film Contest Regulations

Article 1. Denomination

The Corti a Ponte Association herewith announces the 7th edition of the International Short Film Competition named "*Corti a Ponte - official contest*".

Article 2. Entry

Entry to the competition is free, except for the cases listed in article 11. There are no age limts, nor residence or citizenship restrictions.

Article 3. Works

Works must be no more than 3 years old (produced after 01/01/2011). Works already released or presented to oher competitions are adimitted. Each author can participate to the selection with a maximum of two works, regardless of the section they enter.

Article 4. Sections

The competition has three sections:

1. NARRATIVE SHORT FILMS

for live action fictional short films.

2. ANIMATION

for short films created with any animation techique (traditional, stop motion, pixilation, 2D, CG, 3D, ...)

3. MUSIC VIDEOS

for videos especially designed to promote a specific music piece.

Article 5 - Narrative Short Film Section

5.1 Only narrative live action short films cam enter the competition. Video documentaries, art-videos, dance-videos and pictures sequences will not be accepted.

Works participating to the narrative short film section may have either a free or a given theme.

- 5.2 The short films must develop one of the following themes:
- 5.3

Free theme

With no restraints to content and genre.

Bridge

This theme can be analized from every point of view, with any meaning and by any facet. For instance, the film can tell about physical, real, unreal, ancient or modern bridges. The bridge could be metaphorical: the encounter of two different realities, the

breaking of a barrier, getting near someone, ... The theme can also be related to cultural exchanges and relationship between European cities (twinnings).

• UN International Year - Family farming

2014 was declared by the United Nations "International Year of Family Farming", to promote understanding about concepts like:

- Family and small-scale farming are inextricably linked to world food security.
- Family farming preserves traditional food products, while contributing to a balanced diet and safeguarding the world's agro-biodiversity and the sustainable use of natural resources.
- Family farming represents an opportunity to boost local economies, especially when combined with specific policies aimed at social protection and well-being of communities.

The theme can be analized arounf family farming or - in a broader meaning - it can refer to the value of small scale production, to the importance of small things, to the variety and local diversity.

Slowness

This theme is inspired by the Festival of Slowness, a local event built around the concept of SLOW. The theme can be developed around the slowness of a physical movement of a person, an object, an animal, a process or an event. The theme may also be dealt with by using slowness as a narrative style, as a characteristic of the narrative speed or of the editing rhythm. The theme can lead to reflecting about the fact that slowness is not only a physical matter, but also a social necessity, a way to notice the other: listening and dialoguing is the only way to get a proper vision of our historical and human context.

5.3 Narrative shorts must have a maximum duration of 15 '.

Article 6 - Animated Short Films Section

6.1 Works of any subject and any genre can participate in the animation section.

6.2 The animated short films must have a maximum duration of 15 '.

Article 7 – Musical Videos Section

7.1 Both live action and animated videos are accepted.

7.2 Musical videos must have a maximum duration of 5'.

Article 8 - Creative Commons

Corti a Ponte devotes special attention to short films published under a Creative Commons licence, or whose material has been released under a Creative Commons licence (images, screenplay, music, etc).

Only works that express and apply the licence correctly will be eligible for the competition. If the selection committee notices irregularities or improprieties in a valuable work, the film might be admitted under reserve and the author will be required to bring the necessary changes. Authors who used Creative Commons materials or who published the short film with a CC licence are advised to read the Frequently Asked Questions (FAQ Creative Commons) on the Festival website www. cortiaponte.it.

Article 9 - Language

Works have to be in Italian or, if not in Italian, with Italian subtitles.

Works in foreign languages with english subtitles are admitted, but subtitles have to be included in an .srt file with correct time-codes, so that the Organization will be able to translate them in Italian.

Article 10 - How to enter

10.1 To enter the competition author must send the file on one of the following ways::

- Through the on-line platform CLICK FOR FESTIVALS <u>http://www.clickforfestivals.com</u> Fees: Click for festivals charges from 1.5 to 3 euros, depending on how many festivals the author wants to participate to. Entry with private Vimeo link is free.
- On DVD or CD, clearly indicating the work's title and the author's name on the disk. The disk can contain two files. Authors must send also a technical description and an entry form. Disks must be sent to:

10.2. The organizers of the competition are responsible for the custody of all incoming works, but will not respond of any damage or loss during shipment.

Article 11 - Deadlines

Entries must be sent by January 31, 2014.

It's possible to send the films after the deadline upon payment of a 2€ "penalty-fee" and, in any case, by February 28, 2014. The submission date will be attested by the date of the online subscription, of the the mail postmark.

Article 12 - Selection

All received films will undergo a first selection by the Festival Selection Committee. The films selected as finalists will be screened during the festival nights.

Article 13 - Selected Works

If selected, authors may be asked to submit the movie in MPEG-2 PS or VOB format, compatible with DVD-Video PAL or NTSC, without any extra (no color bars, audio tones, 10 seconds blank introduction or similar).

The short films will not be returned. They will become part of the Festival's Archive.

Article 14 – Awards

The finalist works will be examined by a jury composed by experts and field operators, whose names will be made public after the contest deadline. The jury, at its own unchallengeable judgement, will give the following awards:

- 1. best narrative short film
- 2. best animation
- 3. best music video

- 4. best "small scale" short film
- 5. best "Slowness" short film
- 6. best "Creative Commons" short film.

Other awards or special mentions can be conferred at the jury's discretion. The Organization Committee might decide to give a **Corti a Ponte Association Award**. There will be no money prizes.

Article 15 - Screenings

The selected films screenings and the award ceremony will take place during the "Corti a Ponte" film festival, in the Town Hall of Ponte San Nicolò (Padua).

Article 16 – Authorisation

By submitting his or her short film to the competition, the author authorizes its screening during the festival or diring events related to the festival; he or she also declares to own all the rights concerning the use of the submitted work, bar none; that the work contents do not violate any law nor third parties' rights; that the work does not include libellous content. In all cases, the author exempts the organization from any liability for the content of the publicly screened short film.

Article 17 - Regulation

Participation to the festival is conditional upon the complete and unrestricted acceptance of the present rules.

The organisers may amend this Regulation by reason of force majeure or beyond their control, for technical and organizational problems, in order to make improvements or in case this is required by unexpected circumstances.
