Article 1:

Tangier international film festival (TIFF) is an annual manifestation whose main objective is to promote the Moroccan cinematographic culture and multidimensional exchanges as well as supporting innovative expressions.

Article 2:

The (TIFF) is organized every year by CINEMANA Foundation in collaboration with national and international partners; the festival is also accompanied by local and regional authorities.

Article 3:

The films submitted in the competition must be:

- Produced after the 1st of January 2016.

- In the documentary, animation or fiction category.
- up to 30 minutes.

The films must be presented in an original version with English subtitles.

The candidate must send the completed registration form, Vimeo Link with the access code, the film Director's photo and the data sheet of the film before May 30, 2017.

Each jury consists with five distinctive personalities in the field of Art and cinema. No one can take part in this jury if he/she has any relationship with any participating film in the competition.
