Rules & Regulation

Please read all rules and regulations before submitting your project.

Open submissions from: 4 October 2014 - 17 April 2015

2015 FESTIVAL:

- The festival of the season will start from Wednesday, 27 May 2015 until Friday, 5 June 2015. Winning movies will be screened at our partner institutions based on juries' selection.
- Juries will choose one overall winner and gives Golden Awards and Awards of Merit.
- The festival will grant awards during the Awards Day in Jakarta.
- Other awards will be available but only depends on the sponsorship of the festival partners.
- During the festival, we will conduct screenings, filmmaking workshops, and press conference. All winning filmmakers, mass media, government bodies, and celebrities are warmly welcome, free of charge.

REGULATIONS

- Titles produced in languages other than English must have legible English subtitles or dubbed in English.
- Films could be from any year.
- Although every possible care will be taken with DVDs while in our possession, however, we cannot accept responsibility for unforeseen loss or damage of entries. Please do not send originals.
- When your film is officially selected, we will post it on our web latest on Monday, 27 April 2015 and contact you by e-mail.
- If chosen for festival screening, 2 copies high quality DVD (include one bluray disc) or DCP must be sent. Mark case and DVD with title, length, and director's name.
- All international or foreign films should be clearly marked " Not for commercial use - For Cultural Purposes Only" either on the envelope or the shipping invoice or both. DVD's must be clearly labeled with title, length, and director's name. All transportation/ shipping costs (including customs clearance) to Jakarta, plus fees for insurance while in transit, must be borne by the participants and sent pre-paid. The Festival Director reserves the right to refuse any shipment involving unpaid costs.
- The selection committees' and juries' decisions are final.
- WORLD FILM AWARDS reserves the right to make any necessary changes in regulations or scheduling.
- Films selected may not be withdrawn from the Festival program after its registration.
- All submission fees are non-refundable. We will not return your screening and exhibition copies.
- The Festival Directorate may deny participation to any film unable to meet the technical requirements for a public screening of good quality.

LIABILITY

REPRODUCTION AGREEMENT:

Submission of an entry gives the festival permission to have accepted work exhibited, photographed, locally telecast, and reproduced either in part or whole, for educational or Festival purposes. Filmmakers can request in writing that their material not be used for such purposes after the Festival.

CHANGES AND ALTERATIONS

The Festival Management reserves the right to make changes in the profile of the Festival, if it becomes necessary to do so due to circumstances beyond his/her control.

JURISDICTION

All disputes in respect of any matter relating to the WORLD FILM AWARDS shall be subjected to the exclusive jurisdiction of the competent courts in Jakarta.

The duration of this agreement shall commence as of the date of submission by Owner and terminate at the close of the 2015 Festival.
