Eligibility Regulations / Terms & Conditions

- 1. Entries of all films / documentaries (hereafter collectively called Films) shall be accepted only in DVD format.
- 2. There shall be three categories in the festival Mithilanchal, National and International.

Mithilanchal Category: Only the films made by filmmakers of mithilanchal region come under this category. The director(s) or producer(s) of the film must be a resident of Mithilanchal. (A residential proof ID must be attached with the film entry form). The films made by outsiders of Mithilanchal region can't enter this category. The films which are totally made in English language can't enter this category. If some selected dialogues are in English then they can participate. Mithilanchal / Mithila region, a proposed state of India is presently spread along 30 Districts of Bihar & Jharkhand states. These 30 Districts are East Champaran, West Champaran, Muzaffarpur, Vaishali, Sheohar, Sitamarhi, Samastipur, Darbhanga, Madhubani, Saharsa, Supaul, Madhepura, Kishanganj, Purnia, Katihar, Araria, Begusarai, Khagaria, Munger, Sheikhpura, Lakhisarai, Jamui, Banka, Bhagalpur, Deoghar, Dumka, Godda, Jamtara, Pakur and Sahebganj.

National Category: Only the films made by the filmmakers of India come under this category. The director(s) or producer(s) of the film must be a citizen of India. (A document must be attached with film entry form which proofs your Indian Citizenship). The films made by outsiders of India can't enter this category.

International Category: There is no restriction for this category. Any film all over the world can participate in this category.

- 3. Films must be subtitled in English.
- 4. Films may be entered by any organization, agency, individual producer or director.
- 5. Selection of films / videos for Darbhanga International Film Festival will be done by a committee whose decision will be final. However, Festival Authorities reserve the right to accept or reject any film that is likely to offend sentiments, feelings or sensibilities of any caste, community, religion and sector is likely to promote racism or ill will in the society.
- 6. Darbhanga International Film Festival would be allowed to use all photographs and publicity materials received along with the Entry and the same will not be returned to the entrants.
- 7. Censorship will not be applicable to any films / videos entered in the festival.
- 8. The Festival Authorities will have the right to screen the selected films (for awards) in India or abroad on non-commercial basis.
- 9. For promotional / publicity purposes, excerpts from any film entered in the festival may be shown on any Television network / Internet or related media during the festival period.
- 10. Entry Forms with incorrect / inadequate / illegible / ambiguous particulars will not be considered.
- 11. DVDs submitted for selection will be considered as final and no changes will be entertained after submission. It is the sole responsibility of the applicant to submit DVDs without any physical / quality defects.
- 12. Prize and certificate will be awarded to the director(s) or producer(s) of the film.
- 13. Films once selected and submitted for the final screening will not be allowed to be withdrawn under any circumstances, until the Festival is over.
- 14. Participation in the Festival implies acceptance of these Regulations.

15. Decisions of the Festival Authorities regarding all matters not expressly provided for in these regulations or which require interpretation of the clauses mentioned above shall be final and binding on all parties.
