

# **RULES**

#### **PARTICIPANTS**

Any corporation or individual person of any nationality who is over 18 when the work is submitted.

In order to compete, <u>register as a Participant</u> and complete the following information: Complete Name and Last name, in the text box can expand these data including Country and Origin of the Film precedence, Complete and Present Address of the Participant, Passport Number. If any of the questions it is not answered the film will not be shown.

If your Film complies with the rules, you will be sent an e-mail confirming your admission. The Organization, following its own criteria, reserves the right not to accept the works that do not comply with the artistic, technical and/or legal conditions required by the Festival.

#### SELECTION OF FINALISTS

The Organization of the Festival will make the selection of the Finalists Films. The Decision will be announced and published in Animacam on January 10<sup>th</sup> 2017. The Organization Decision will be unappealable.

### **FILMS FOR COMPETITION**

SHORT ANIMATION FILMS FOR ALL AUDIENCES produced by using the technique of participant's choice (2D, 3D, Claymation, Stop Motion, Mixed Thecnique...) and in any form (Fiction, Documentary, Video art, Multimedia...).

FILMS MAY BE UP TO 35 MINUTES LONG.

\_\_ORIGINAL WORKS (NO LIMIT ON THE AUTHOR) ENDED OR RELEASED DURING 2015-2016.

WORKS SHOWED IN ANIMACAM BEFORE CANNOT BE PRESENTED.

\_\_FILMS MAY BE SILENT, MUSICAL WITH OR WITHOUT DIALOGUE, WITH OR WITHOUT OFF-SCREEN VOICES, IN ANY LANGUAGE.

# **REQUIREMENTS**

\_UPLOAD YOUR FILM AT WWW.ANIMACAM.TV LOGIN YOURSELF AS A "USER".

FILMS COMPETING MUST COMPLY WITH THE FOLLOWING CHARACTERISTICS:

MB: NO GREATER THAN 200 MB // SIZE: 720X405 PIXELS.

FILMS MUST BE ACCOMPANIED BY A REPRESENTATIVE POSTER OR STILL (KB: NO GREATER THAN 500 Kb // SIZE: 800X600 PIXELS.

A PHOTOGRAPH OF THE DIRECTOR OR PERSON LEGALLY RESPONSIBLE FOR THE FILM SHOULD BE INCLUDED: KB: NO GREATER THAN 500 Kb // SIZE: 86X86 PIXELS.

#### **RESPONSABILITIES**

#### THE PARTICIPANTS WITH FILM FREELY DECLARE AND ACCEPT:

- 1.- That they are the only responsibles of the Film or Films they present and of everything included in them (images, music, soundtrack, etc.), either they contest as Authors, Directors, Producers or Legal Representatives. The Organization of Festival Animacam and the production company Limaia Produccións S.L. decline any legal responsability over the Films at contest and their contents.
- 2.- Either Participants as Finalists and Winners, solely for taking part in the Festival, from 10th to 27th January 2017, will freely transfer the rights of public communication, reproduction and transformation to the Organization of the Festival and to Limaia Produccións S.L. for the use of their Films or part of them with the aim of promoting it.
- 3.- Those who become Winners accept that their Film will be on Animacam's past editions record indefinitely. In case the authors don't want their film online indefinitely, a teaser or trailer will be required.
- 4.- Those who become Finalists accept the freely exhibition of their films In the Museo de Arte Contemporáneo Gas natural Fenosa and in WWW.ANIMACAM.TV from 10<sup>th</sup> to 27th January 2017.
- 5.- Participation with Film in the contest implies compliance with this Responsabilities and therefore with the whole Rules of the Festival.
