Rules & Regulations

IMA Documentary Short Film Festival 2014 is a Non-Competitive Film Festival.

The film category, which is included in the festival, is Documentary and Short Fiction.

Works that are produced before 30th July 2014 are eligible for Festival 2014.

All films must carry English Subtitles.

Anyone can submit their film to the festival.

Festival is open to all Organization / Agency / Independent Producers / Independent Directors.

Films produced on any format can be submitted.

All the films should have a total running time, including front and back credits.

Dubbed/revised/copied version of a film shall not be eligible for entry in the festival.

Violation of provisions of the Copyright Act, if proved, will result in a bar on the entry of the film.

Entry materials submitted will not be returned to the contestant.

By submitting a film, all participants give the organiser, IMA Documentary Short Film Festival 2014 the authorization to the catalogs and publications, as well as on the website, all the information, including photos. The organiser, IMA Documentary Short Film Festival 2014 will share the information with its publicity partners.

Although participants enjoy freedom of expression in creating their works, their productions must not either in the film or associated posters and documentation:

- A. Contain hateful, racist, sexist, offensive or defamatory statements.**
- B. Cause harm to anyone.**
- C. Constitute an invasion of privacy**

All films which are selected / nominated for the Festival, will be informed by emails & listed on our website www.bolgattyfilmfestival.webs.com

The list of selected films will be available on IMA Documentary Short Film Festival's website from November 20, 2014.

All participants will get an e-certificate.

Films once selected & submitted for final screening will not be allowed to be withdrawn under any circumstances until festival is over.

Programs composed of films may be circulated after the Festival for its promotion in India and abroad.

Organizers reserves the right to not screen any film for any reason it deems valid.

The organiser, IMA Documentary Short Film Festival 2014 reserves the right to cancel any submission or take any suitable measure in the event of a breach of regulations or in response to any behavior disturbing the course of the festival.

Organisers reserve rights change or re-schedule the dates, venue, awards & categories without information to contestants.

The code of conduct will have to be strictly followed by the entrants; misbehavior will lead to disqualification & legal actions.

The organiser, IMA Documentary Short Film Festival 2014 or its representative will settle all non-specified cases within the terms of the present regulations and may allow special dispensation regarding justified and specific requests.

A person submitting an entry for the IMA Documentary Short Film Festival 2014 shall be deemed to have accepted these Regulations.

The organiser, IMA Documentary Short Film Festival 2014 reserves the right to refuse the registration of any work/film/person or institution for violating any of the above.

In case of litigation, only the courts of the city of Thrissur in Kerala, India.
